### Korean War POW/MIA Report (JPAC)

*Our friend, Phillip A. O'Brien, OSD-DOMO submitted the following update on recovery and identification work.*

Just a quick note to wish you all a Happy Thanksgiving, a Merry Christmas, and a Happy New Year. A lot has happened this year and we're expecting even greater events in 2009. In passing, I'm writing a bit before the Presidential Election, at the end of October. More on that in a moment! Meanwhile, so far in 2008, Joint POW Accounting Command (JPAC) has successfully identified the remains of 17 service members from the Korean War and sent them home to their families. About 10 others have completed their laboratory work and are now being presented to families. We don't consider an identification "done" until the family had been advised and the remains are formally accepted.

**SURVIVING SPOUSES:** Veterans Benefit Improvement Act of 1996 allows the surviving spouse an entire month of compensation for the month in which the veterans dies. It also authorizes payments of accrued benefits for up to two years (instead of one) in the event of the Veteran's death before final adjudication of a claim. SECTION 1318, Benefits for survivors of certain veterans rated totally disabled at time of death. SECTION 1318(3) the veteran was a former prisoner of war who died after September 30, 1999, and the disability was continuously rated totally disabling for a period of not later than one year immediately preceding death.

There is no means test to qualify for the VA Widow's benefit, Dependency and Indemnity Compensation (DIC). For compensation it does not matter what your income or assets are.

Those identified this year include both battlefield losses and POWs who died en route to permanent camps on the south bank of the Yalu River. They also include men whom our teams recovered in North Korea through 2005, and remains turned over by the North Koreans in 1990-94 and 2007. I expect the pace to pick up in 2009 for a couple of important reasons. Those identified this year were “tabled” one at a time in the main laboratory at JPAC on Hickam Air Force Base. Several of these men came from group burials, with initial examinations and “re-articulations” of the skeletal remains done on three or four tables. But then those tables had to be cleared, to enable other identifications, and the final work was done on one table, one man at a time.

Early next year, JPAC will open a new, secure, expansion facility just across the fence at Pearl Harbor. A special, temporary laboratory will be set up there, and the open room will have as many working tables as we need. Large group burials, including those from the Unsan Battlefield, the Suan Bean Camp and Suan Mining Camp, and the Chosin Reservoir area can be brought over. The temporary storage cases can be re-opened, and as many as five or six tables used to re-articulate the remains of several men. Identifications will still be done one at a time, out of respect for the men concerned, but they will follow much more rapidly, one after the next, and with no need to interrupt work as other high priority needs arise. This is a dream come true for the anthropologists at JPAC. They will still be scheduled for field work, here and there around the world. But when they return to JPAC, they know that they will have the tables they need to complete identifications already begun.

This leads to a couple of other questions. What about exhumations from the National Memorial Cemetery of the Pacific, “the Punchbowl?” To date, 11 have been done with six identifications. The question of table space has affected this process, as well. But right now, laboratory work on the seventh man is nearing completion, and several other exhumations are planned for 2009.

The next, obvious issue, when will our recovery teams go back into North Korea? This question has not been forgotten. Those who know the issue well are looking at it closely. If we do return to North Korea, it may be first to the Unsan battle zone, where a previous base camp was located, but none of us knows for sure. We hope to hear more about this in 2009. Events will unfold at their own pace.

## Nationwide Compensation Seminars

Of the 26 million veterans currently living, only a handful are aware of the benefits that are eligible to them. An even smaller number are aware of how to obtain their benefits. As a result, U.S. Veteran Compensation Programs announced today they have developed a traveling Benefits Team that will host seminars around the country.

The Benefits Team is responsible for visiting those areas of the country where there is a high concentration of veterans. Traveling from city to city, the Benefits Team will help veterans understand the benefits process, how to navigate through governmental bureaucracies, how to develop strategies that will surely manifest in benefits for veterans, and connecting veterans with the right people and organizations to get the compensation process started.

## Updates

### Purple Heart For Those Who Died In Camp

On October 6, 2008, Department of Defense announced the approval of a Purple Heart for those who died while a POW since December 7, 1941.

Family members with questions about this change in regulations may make contact with the respective branch of service. It is not known at this time if family members beyond mothers and fathers, sisters and brothers and children of the POW would be able to apply for this medal.

ARMY: Military Awards Branch, 703-325-8700.

NAVY: Navy Personnel Command, Retired Records Section, 314-592-1150.

AIR FORCE: Air Force Personnel Center, 800-616-3775.

US MARINE CORPS: Military Awards Branch, 703-784-9340.

Those who were killed in POW camp and who have been awarded a Purple Heart would not qualify for this additional award. Those wounded in camp and who were awarded a Purple Heart for that wound and who died of other causes later on in captivity should qualify for this additional award.

**COMPENSATION:** I have talked to many Ex-POWs who still are not rated at 100% permanent, many have the **unemployability** rating at 100%. Those rated at 100% permanent and whose other disabilities add up to at least 60% automatically receive "House Bound." This means additional dollars in your VA Check. For an Ex-POW, including an allowance for the wife, his check would be for \$3062.00. This will increase by 5.8% as of 1 December 2008.

If you are among those losing out it is recommended you reopen your claim for PTSD by sending a very short note with your C-number and SSN to your VA Regional Headquarters. Ask them to reopen your claim for PTSD because your condition is getting worse. They will set an appointment at your local VA Hospital via C&P and that will give you a shot at increasing your disability to 100% permanent. If you do not have enough other disabilities to add up to 60% then reopen a claim or open a new claim for one of your disabilities.

Oh, I'd mentioned elections. Friends from overseas had asked about ours, and the answer worth repeating. Our system is very unusual in that the election cycle is fixed. It happens every four years, plus a two-year mid-cycle for the House and some Senate seats. In most Parliamentary governments, elections can be called at different times, either to affirm a party in power or to replace it. Beyond that, our Electoral College system works to form clear majorities. Coalition governments among three or four parties may be common in other countries, but they are unheard of here. The upshot is that in January 2009, a new House, a refreshed Senate, and a new Administration will take up our work anew, as well as many other tasks. Ours is a nonpartisan question, ultimately it serves all Americans, so we'll be pretty busy regardless of specific outcomes. But this is a good time to remember our new President, whoever he will be, in our prayers. Ours is a necessary task, and in the sense of doing right by service members and their families, a joyous one.

## Veterans Records

Veterans can now permanently store their service medical records (SMR), legal records, or military records in the VA's new, user-friendly, Records Archive Division (RAD).

Using RAD, veterans can also gain access to their records with promptness and accuracy. According to VA statistics, it can take a veteran up to six months to get their records after a request has been made. Using this service, a veteran can receive their records in three business days or less. Rather than contacting multiple agencies to request records, a veteran can now make one stop and have their records faxed or mailed to the agency of their choice.

The Health Insurance Portability and Accountability Act of 1996 (HIPPA) entitles veterans to have copies of their medical records on request. Through RAD, veterans have access to any of their personnel records stored with speed, efficiency, and accuracy. A veteran can also request to have their records sent to any agency or provider in a timely manner. Veterans may also supply contact information to their providers and have them fax records to RAD for immediate security and storage.

## Looking for Information

**Wilkes, James (J.T.):** Deana is trying to locate information on James who was either a P.O.W. or was wounded in battle and died in Washington DC or the Philadelphia area, around the early 1950's. She can't find him on any of the military indexes.

**Geyer, William Norbert and Bradley, William C.:** Robin has been trying for some time to locate any information regarding an Ex-POW, by the name of William Norbert Geyer. He mentioned her missing Uncle, William C. Bradley, in his debriefs and she is wondering if there may be a family member who she can speak with. Her Uncle was a medic in the same medical unit as Geyer (who was a Master Sergeant in Medical Company, 9th Infantry Regiment, 2nd Infantry Division). He reported that her Uncle died of pneumonia on December 15, 1950. Mr. Geyer mentioned two other POW's George W. **Crawford** and Jackie N. **Carveau** who attempted escape with him in August of 1952 and returned to Camp 2.

**Hillen, PFC James William:** Marlene is looking for anyone out there that might remember her uncle and know what really happened to him? He served with 19th Regt. 24th Div. was on the Tiger Death March.

**Ivanushka, Michael:** Aaron is the grandson to ex-POW Michael Ivanushka and is looking for anyone who knew him or may have any photos of him.

**Thompson, Jackie Ray:** Randy is searching for information about his father. He was captured 12/2/50 and held at Camp 3 then released by exchange 8/25/1953. He died in 1978.

**Lorenzo, Capt. Michael J; Pickett, Theodore; Chester, Earl:** COL. Ali Denizli, Turkish Ex-Korean POW, is seeking information on these P.O.Ws or any POWs from 2 Division that was with the Turkish POWs.

**Bishop, Danny M:** Doug is looking for anyone who knew his uncle, Danny Bishop.

**Ross, Tommy Eugene:** W.A. Ross is seeking information on his brother, Tommy. Tommy was a Medic with the Ambulance Platoon, Medical Company, 9th Infantry Regiment, 2nd Div. He was taken prisoner while tending his wounded comrades near Kunu-ri, North Korea, on December 1, 1950 and died on or around March 31, 1951 in Camp 5.
